**STEP 1** Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool. Remove main fuse.

**STEP 2** Refer to PIC 1 and 2. Disconnect and remove existing rear light bar.

*Note: Removal process may vary between models, refer to service manual for assistance.*

**STEP 3** Refer to PIC 3 and 4. Remove license plate bracket from the existing light bar.

**STEP 4** Refer to PIC 5 and 6. Remove the license plate L.E.D. light from the light bar. Cut the harness wires connecting the harness to the two individual lights on the light bar.

**STEP 5** Refer to PIC 7 and 8. Locate Turn Signal Light Bar and Hardware Kit.

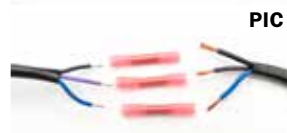

**STEP 6** Refer to PIC 9 and 10. Splice turn signal light bar wires with the newly cut harness wires, using the provided six (6) sealed butt connectors. Connect the blue to blue, the purple to purple, and the black to black.

**STEP 7** Refer to PIC 11. Align and fasten the L.E.D. license plate light to the light bar, using the provided two (2) 6-32 x .3" button head cap screw.

**STEP 8** Refer to PIC 12 and 13. Align and fasten the license plate to the new light bar, using the provided two (2) 1/4-20 x .50" button head cap screws and two (2) split lock washers.

**STEP 9** Refer to PIC 14 and 16. Feed wiring harness back through the larger hole in the rear fender. Align the light bar assembly with the two mounting holes in the rear fender. Be sure the supplied gasket on the light bar is properly in place. Locate OEM hardware removed in Step 1 and fasten light bar to rear fender. Fully tighten hardware.



**STEP 10** Install the new light bar in the reverse order the old one was removed.

**STEP 11** Reinstall main fuse. Check to make sure all lights work properly before riding bike.
